Officer Reports

Secretary's Report

On the same theme I would like thank all those clubs who have returned their nominations for next years Representative games, on time, very helpful, they will be passed onto the 3 selectors later this evening.

I would also like to thank the 16 clubs who returned their Green Testing Forms back to us at the beginning of the season, so they could be viewed on our website for everyone to see, hopefully next season will see the same response. (Thorpe Bay requested that we change their 'paired' club for next season)

I realise that not all clubs have held the AGM's yet, and you don't know who exactly your club officers will be for next season, I will e-mailing all the current delegates early in the New Year asking you to confirm the contact details for your Group 6 delegate and club secretary for the 2019 season. This information will be forwarded to the County Secretary for inclusion in next years County Handbook. I would request that you reply as soon as you can so we can ensure next years County handbook has up to date information.

Group 6 would like to formally thank Essex County Bowling Club for the use of their facilities and the help of the club members to make it a successful day.

Finally, I would like to encourage all clubs to use the Group 6 website for all the latest information about Group 6 bowling.

I addition to all the normal information on leagues, representative games, green testing etc, next year we are hoping to publish more details on the friendly games such as names of players in advance of the games as well as the final results.

Treasurers Report

Everyone should have received a copy of the latest accounts for information.

As always the financial objective of the Group is to break even each year and with a fixed income of £670 per year our expenses are reasonably predictable, with shirts, printing, engraving and website costs being the most predictable, after these costs we are left with around £120 for one-off expenses.

The cost that does vary and is directly linked to our competitive bowling success is green fees, the more successful our Ashford Cup, Wally Ball and Inter Group Knockout Teams the larger our expenses. I would request that the selectors be less successful.

At this point, Dave Starkey stated that the selectors have made a decision that from next season all players in the above games would be charged a £2 rink fee, this not being unreasonable for this type of game and in fact in most games this season, players were offering to pay a rink fee.

The selectors feel it would be prudent to make the charge now while our accounts were still healthy than wait until it was imperative to spend less.

Chris accepted the decision but explained from a purely financial perspective it was not needed at this time.

The Secretary was requested by the selectors to formally ask the club delegates present if they had any objections to their players, who are selected to play in the representative games, be asked to pay a £2 green fee, the meeting unanimously agreed to the proposal.

County Competition Secretary's Report

Firstly the more observant of you will have noticed this year that the County Fours competition format was very different, with the first three round taking place in the same gauge how it would work going forward.

I would like to thank all the players and sponsors in this competition for their efforts in making the format work without too many complications.

From next season this one competition will revert back to its traditional day on a Friday.

The other item I need to raise was more of an embarrassment than anything else; if players change clubs between completing the competition entry form and playing the first game they cannot take that competition entry into any competition other than the singles.

For example:

If you were a member of Bournemouth Park when you completed you County competition entry form and you then moved to Essex County between seasons, the only competitions you can play are the singles, all the other team competitions are null and void, and cannot be played. You cannot transfer your team competitions entries from one club to another.

The only exception to that rule is; if the club that you made the original entry from ceases to exist, you are then allowed to play for one season only, under the name of that club. This is covered in the County handbook under competition rule 1.c page 34

Jim Bunce asked the question; if a player has entered the County Fours competition (his name is on the entry form) and then left the club, could the other three players in the team take over that entry and bring in a fourth player to replace the named player on the entry form, and play the game. The four players who play the first game would constitute the team and they could then be allowed to bring in a substitute for one of the players. This being justified because it is the club that makes the entry, not the players.

No one could confirm with 100% certainty that this was allowed and the meeting agreed that our County Delegate would raise this question with the County Competition Secretary at the next executive meeting.

The results for County competitions this year went relatively smoothly, I would like to thank everyone who phoned their results through to me on the evening of their game. It meant I was able to send my results spreadsheet through to the County that evening and the website is updated straightway without any delay.

Group 6 were will represented in the County Finals this year and anyone who came along to watch the finals witnessed some very good games.

Group 6 would like to congratulate Ed Morris from Essex County Bowling Club for winning the National Two Wood Final this year, a great achievement.

Ed Morris also became a full International this year at Leamington.

Ed Morris and James Fuge also won the County Pairs and went on to win the Eastern Counties Pairs Final, another great achievement

The Shoebury Park delegate asked the Competition Secretary if he could raise with the County Competition Secretary why players from more than one club cannot play together as a team in County Competitions. He feels this is discriminating against smaller clubs who haven't got the numbers to support one team but have players who would like to play in these competitions. This rule is forcing competitive players to move to larger clubs to player in County team competitions.

Richard will take this forward to the County.

League Secretary's Report

All the leagues ran smoothly this year with results being reported generally on time. We had a few games that needed to be rearranged because of players competing in the County Fours but those games were fitted in, just.

Thanks to all clubs for getting their results in promptly this allowed me to publish the league tables on time.

For next season, Bournemouth Park have withdrawn one team, Fairwood and Castle Point are both adding a team, so it is proposed to keep 6 divisions, with 8 teams in divisions 1 - 5 and 9 teams in division 6.

We will repeat the system we used the last time this happened which seemed to work OK, Division 6 teams will play through the normal two week break in early June and they will play two games in a week at the end of the season.

Finally congratulations to the league winners and I look forward to summer 2019.

Selectors

Ashford Cup – Another good year for Group 6 with us again reaching the final. A superb win at Grays was followed by two good performances at Frinton and Thorpe Bay.

It was especially pleasing to qualify for the final after having two away games.

The final at Thorpe-le-Soken was a close contest until the last few ends when we fell away. We drew three rinks each but our shot difference cost us the win.

I would like to thank my fellow selectors and all the supporters that travelled to the game. My congratulations to all the players who achieved their County Badge this year, especially Jerry Telling from Bournemouth Park who became a County Champion.

Next season we will be playing our home games at Essex County.

The selectors are discussing the possibility of having a trial game at the beginning of next season, do the delegates here today think we should, the meeting agreed to a trial game.

Match Secretary

We have spoken previously about playing some friendly games within the group to increase profile of Group 6 as a group.

I sent out to all the Group 6 clubs a questionnaire asking if clubs would be willing to provide one rink of player (4) to participate in any organised friendly games. I am please to say I received 16 positive replies from the 23 clubs.

The four friendly games were arranged towards the end of the playing season so to avoid clashing with competitions etc.

Of the four games organized only three took place, the fourth against Prittlewell was cancelled due to the very high temperatures that we experienced during August, in hindsight this was the right decision.

When it came to the selection for each game, I sent a letter to the Secretary of each of the clubs that would provide players, I did this on the basis that 'in my opinion' any correspondence should be sent to the Club Secretary who would pass of to the relevant club officer.

Following a brief discussion the delegates felt that any correspondence should be sent to both the Club Secretary and Delegate, this should ensure that at least one club officer will deal with the matter, Ken agreed to do this next season.

This follows Ken's experience this season where one club had difficulty responding to his letter.

A problem where one club who did not provide a rink for one particular friendly, which resulted in the Match Secretary paying for the rink fees etc. out of his own pocket was resolved on the night of the AGM

We have two games already fixed for next season against ECBA Vice-Presidents and Southend BC, the game against the Parks Circle I hope to play at Hockley BC if possible.

The Whitehall delegate expressed his thanks for an excellent days bowling at Southend.
