### **5. Officer Reports**

# **Treasurers Report**

At the start of the year we had a bank balance of £2171.96 over the year we had a surplus of £404.40 giving us a closing balance of £2576.37.

As usual, by the end of the year we have received the following years affiliation fees and league entry fees. These, as usual will be included in next year's accounts but mean the actual end of year bank balance is £2976.37.

As well as the affiliation and league entry fees the other main source of income has been the subsidy paid by ECBA. Part of this money is to help cover travel costs of Group officers to matches; Ashford, Wally Ball and Intergroup. This year, as in previous years, our officers have not takes these expenses. This accounts for a large part of our surplus.

This year we decided to change the Group 6 shirts. There will be an ongoing annual cost for this, it is adequately covered by our reserves.

The Affiliation and League Fees, supplemented by part of the ECBA subsidy cover our normal annual expenditure.

# Secretary's Report

Firstly, I would like to thank every club for returning your 2026 Affiliation Fees & League subscriptions on time, this has allowed us to present you with some options for next year's League structure at today's meeting rather than later. Thank you

So next year, Group 6 league will be maintained at 21 affiliated clubs. with no further withdrawals

I would like thank those clubs who have returned their nominations for next year's Representative games, I have only received 20 nominations for the Ashford Cup. so far, so if you have forgotten, it is not too late, just email me a copy please.

I would also like to thank the 16 clubs who returned their Green Testing Forms back to us at the beginning of the season, so they could be viewed on our website for everyone to see, hopefully next season will see the same response.

As last year, you will be receiving emails directly from the ECBA regarding your 2026 Affiliations Fees and your club contact details for next seasons County Handbook.

On the subject of County Affiliations I would like to draw you attention to one matter that could have major ramifications for us all in the years to come.

Sport England who provide funds to both outdoor and indoor bowls nationally have asked the question, 'why are there two national bodies', could this be reduced to one that covers both indoors and outdoor activities.

Consultants have been appointed who are looking at the ramifications of this change.

There are major differences between the two organisations, one being finance, with Bowls England having significantly greater funds than the EIBA who run the indoors. This is simply because there are 100's of outdoor clubs who pay affiliation fees but relatively few indoor clubs.

Another significant difference is paid staff, where Bowls England have dozens and the EIBA have 4. They both have a paid CEO. which would be reduced to one.

This issue is unlikely to have any impact on us as clubs for many years, maybe the end of the decade, but change is inevitable.

As last year, I will also be asking you to provide me your club contacts for 2026, once received I will forward to complete list to all club secretaries and delegates.

Our Group 6 competitions returned this year, with 27 entries in the Singles and 20 in the Triples. All the rounds were completed on-time for which I would like to say thank you to all the players.

The SINGLES was won by Alan Eldridge (ECBC) who beat Duncan Barton (TBBC) by 21 shots to 14.

The TRIPLES was won by Gary Telling (sub-Ray Bone), Malcolm & Alan Eldridge from Essex County who beat Steve Gymer, Allan Peterson and Keith Lucock from Fairwood by 22 shots to 6

I would like to say a big thank you to Rayleigh Bowling Club for hosting the finals this year, they proved excellent hosts and together with a lot of support for the players, (especially from Fairwood) everyone had a very good morning, in which the weather also played its part.

Once again, I would like to encourage all clubs to use the Group 6 website for all the latest information about Group 6 bowling.

In addition to all the normal information on leagues, representative games, green testing etc, we are putting more and more information on our website

A lot of time goes into ensuring that it contains all the latest information about Group 6 bowls as well as bowls across the County, so please use it.

I would also like to mention the great job Paul LaPlain from Essex County did this year as County President, he certainly represented Group 6 very well.

# **League Secretary's Report**

The league ran smoothly this year with results being reported generally on time and with the league tables updated within days of the games. Only one game was left unplayed, due to player unavailability at short notice.

For next season, we have the same teams being entered as in 2025, so there is no need for any restructure. This is, of course, dependent on the motion proposed by Bournemouth Park.

The Officers are presenting a motion to formalise the switchover to Wednesday evenings as we have received no specific feedback from the clubs.

The Officers are also presenting a motion later in this meeting to change the league rules to clarify the situation relating to the number of ends that can be agreed upon in the case of expected bad weather.

Finally, congratulations to all the Divisional winners and I look forward to summer 2026.

# **Match Secretary**

2025 has been a difficult season to arrange the same friendly fixtures that we have had in the past.

To try and overcome this situation I was able to arrange one new fixture with the Chelmsford & District B.A., which was played on Thursday 28th August. I have now established this fixture as a regular game going forward.

This game was a replacement for the Essex Vice-Presidents game that was played at Essex County and the Chelmsford B.A. always enjoy playing at ECBC.

This fixture has been confirmed for 6 rinks on Thursday 27th August 2026 at ECBC

Unfortunately with regard to the Essex Vice-Presidents, there was difficulty arranging a suitable date for 2025, I have tried to resurrect this fixture for 2026, offering a spare date in early September, but to date I have not received a response. As a result we will not be playing the Essex V.P.'s in 2026

The usual fixture with the Southend Park Circle could not be arranged due to their difficulties finding a fixture secretary.

To replace the Park Circle fixture I have had preliminary discussions with the Basildon & District B.A. about a fixture in 2026

The one disappointment for me is the difficulty that clubs have in providing one rink of four male players and their playing positions, in a reasonable time.

I try and give the clubs a reasonable amount of time before I call their secretary with a gentle reminder that I need four male players, the response is very often, they cannot find four players to play.

My instruction in previous AGM's has been to contact the club secretary and delegate with my request, as a result of the poor responses we will now include the club captain.

In conclusion. I wish everyone a healthy winter and if bowling indoor, enjoy.

#### First Match v Group 1 at Prittlewell

3 bowlers pulled out of match from 1<sup>st</sup> selection 1 bowler retired after 5 ends possibly caused by the green had not been cut for two days (GREEN VERY HEAVY). The match did not go well only 4 points out of 8 shot difference -16

Lots of moans about playing surface by players.

We spoke to Prittlewell about the green condition we were informed that the green had not been cut since Friday Southend Council would not cut the green on Sunday before unless they were paid. I understand Group 6 chairman suggested that the group 6 paid for the cutting to be done before the next match on Sunday the group Treasure agreed.

#### 2<sup>nd</sup> Match V Group 8 at Prittlewell

Group 8 had lost their  $1^{st}$  match 8-0 So with a little bit of luck and some good bowling and the green being cut just before the match we could do well 3 changes to the front end of 2 rinks right from the start there was some moaning about the pace & line it was still very heavy but the same for both sets of players. I was disappointed with some of the bowling unfortunately being a bowler I have been there myself so I know what they must have felt like again 4 points out of 8 shot difference -8

at least that was better than last week. So it will all be down to the last match against Group 4 needed to win by 8-0 with a very good shot difference a very big ask.

Made some slight changes moved 2 players around & brought one player in Ray Woollard stepped in for me as I was not available on match day no reserves turned up thank you Ray for bringing your bowls in case you were wanted Same result as the other matches 4 point out of 8

### Motion 3. Proposal received from Bournemouth Park B.C.

All Group 6 League games to start at 5:30pm

The general view of the meeting was that starting earlier every week would potentially prevent some bowlers, especially those that work from bowling in the Group 6 league, which was counter to everything that Group 6 works for.

The Group 6 Officers suggested that clubs could play at any time on the scheduled day, as long the opposing club agreed.

The League Secretary promised to update the league rules to include this addition information.

O A hand vote was taken (delegates only) with the majority rejecting the motion

#### Motion 4. Proposal received from Bournemouth Park B.C.

Only one badged player to be allowed to play on each rink in Group 6 League games

The general view of the meeting was that this would prevent a significant number of bowlers from a lot of clubs bowling in the Group 6 league, which was counter to what Group 6 works for.

O A hand vote was taken (delegates only) with the majority rejecting the motion

#### Motion 5. Proposal received from Bournemouth Park B.C.

All teams from Essex County B.C. to play in their own division within the Group 6 League, with no promotion/relegation

The delegate from Prittlewell B.C. asked if Group 6 could do anything to prevent clubs from putting wet weather mats down in the height if summer when the ground is 'rock hard'. In his opinion it ruins the game without any good reason.

Various delegates expressed the view that Park Circle clubs and others who didn't own their own green were influenced by the local council's greenkeepers when it came to putting mats down and sometimes the clubs didn't have a choice.

It was also stated; that within the 'Rules of Bowls' it was at the discretion of the home club and its greenkeeper to play with mats down if they think their playing surface will be damaged during the game.

In summary; Group 6 cannot impose rules on Group 6 clubs as to when games are played with mats down.
