2. Secretary's Report

Inter Group Knockout Selector

CF informed the meeting that he had received an email from Alan Simpson, stating that Alan would be stepping down from his selectors position with immediate effect, this due to business and medical reasons. The Secretary has written back to Alan thanking him for his contribution to Group 6 activities over the last few years, wishing him well and hoping that we might see him return to the committee at some future point.

3. Review of the latest Bowls England COVID guidelines

CF had previously circulated to committee members a copy of the Bowls England 'Return to Play' Step 3 guidelines.

The guidelines now state that organised bowls can return to normal play in all formats from 17th May.

This will allow all Group 6 activities to resume as per the original schedule with all activities i.e. Leagues, Ashford Cup, Wally Ball. And Inter Group Knockout being played on the planned dates and venues in the original formats.

All clubs have been sent a copy of this document and those clubs who were standing by as additional venues have been informed.

4. Group 6 League

Having received the guidelines above, an email has been sent to ALL Group clubs informing them that normal play i.e. ALL 6 rinks can be used for Group 6 league games, will be anticipated from 18th May. Any clubs who cannot comply with this request should contact the League Secretary.

There are still restrictions applicable to food being served indoors. Group 6 committee still believe that decisions on the serving of food at Group 6 league games should be the decision of individual clubs.

The Secretary will send an email to all clubs with the above information.

5. Representative Games

• Ashford Cup

The Secretary has received an email from the County Match Secretary confirming that the Ashford Cup will now proceed as per the original match schedule. **JB** confirmed that the team for the first game has been selected and published and sent to all clubs and players asking for confirmation of their availability by Sunday 16th May.

Wally Ball

DS confirmed that the Squad and team selection for the first game is near completion and hopefully will be ready for distribution later this week. A squad of 19 players is looking a distinct possibility.

DJ informed the meeting that due to health problems he will not be bowling this summer and unable to be part of the Wally Bally squad. The committee wish him well with his treatment and hope to see him return to bowling next season.

• Inter Group Knockout

With the resignation of Alan Simpson, the committee need to find an alternative selector. **KR** suggested that Kevin Watkins is the ideal candidate to fulfil this role and **KR** would be available to support this function. It was agreed that the Secretary would approach **KW** and ask him. In the event that **KW** refuses the committee could share this role between them.
